Injuries from slipping / tripping	Customers Staff	<ul style="list-style-type: none"> <li>▪ Skate park floor cleaned daily in accordance with the cleaning schedule</li> <li>▪ Area checked regularly by staff</li> <li>▪ First aider available on site throughout opening hours</li> <li>▪ Multiple first aiders on site at all times including all instructors.</li> <li>▪ First Aid supplies available</li> <li>▪ Accidents recorded on Accident Report Forms</li> </ul>
Spillages of water on floor causing slips	Customers Staff	<ul style="list-style-type: none"> <li>▪ All spillages cleaned up immediately</li> <li>▪ First Aid supplies available</li> <li>▪ Accidents recorded on Accident Report Forms</li> </ul>
Equipment storage	Customers Staff	<ul style="list-style-type: none"> <li>▪ Equipment stored in locked store room</li> </ul>
Unauthorised access	Customers Staff	<ul style="list-style-type: none"> <li>▪ Doors operate on a Maglock system/staff activated only</li> <li>▪ Disclaimers forms must be signed/checked before entry</li> <li>▪ Coloured band system in place for sessions</li> </ul>
Damaged surface		<ul style="list-style-type: none"> <li>▪ Area checked daily</li> <li>▪ Defects procedure in place</li> </ul>

**Risk: Collision**

Collision with other person, wall or equipment	Customers Staff	<ul style="list-style-type: none"> <li>▪ Spectators must watch from the cafe</li> <li>▪ Children under 18 must wear helmets &amp; we strongly recommend that they wear pads as well</li> <li>▪ Skate park always marshalled by at least 1 person</li> <li>▪ Multiple first aiders on site at all times including all</li> </ul>

Equipment storage	Customers Staff	<ul style="list-style-type: none"> <li>▪ Where possible, equipment stored secure area or area where staff are present</li> </ul>
<b>Risk: First Aid</b>		
Lack of First Aid provision	Customers Staff	<ul style="list-style-type: none"> <li>▪ See First Aid Risk Assessment</li> <li>▪ First Aid supplies available</li> <li>▪ Accidents recorded on Accident Report Forms</li> </ul>
<b>Risk: Glazing</b>		
Equipment impact with glazing	Customers Staff	<ul style="list-style-type: none"> <li>▪ Toughened glass in accordance with British Standard BS6206(A)</li> </ul>

<b>Risk: Environment</b>		
Pigeons in skate park	Customers Staff	<ul style="list-style-type: none"> <li>▪ External company hired to do the hawking</li> </ul>
Noise / Communication	Staff Public Lifeguards	<ul style="list-style-type: none"> <li>▪ Staff have walkie talkies to communicate to reception &amp; the Duty Manager</li> <li>▪ Noise risk assessments in place</li> </ul>

Temperature	Staff & public	<ul style="list-style-type: none"> <li>• Temperature guidelines followed</li> </ul>
Crowded Skatepark	Public	<ul style="list-style-type: none"> <li>• Coloured band system to account for numbers, to prevent overcrowding.</li> <li>• Marshals in skatepark to maintain numbers.</li> <li>• Marshals to ensure behavior and etiquette is maintained.</li> </ul>
Lighting – Lux levels	Staff & public	<ul style="list-style-type: none"> <li>• Daily inspections</li> <li>• Light levels as per recommendations</li> </ul>
